

TERMS AND CONDITIONS OF ACCESS OR USE

1. Introduction

1. Parihaa (hereinafter referred to as "Parihaa", "we", "us", or "our") provides online courses and conducts online classes, live demo, doubt clearing sessions for the students seeking to enrol for such courses (the "Services"), which Services are accessible at www.parihaa.com and any other websites through which Parihaa makes the Services available (collectively, the "Site ") and as applications for mobile, tablet and other smart devices and application program interfaces (collectively, the "Applications").
2. Whether or not you have registered with the Site and/or Application, by accessing or using the Site, Application, or Services, or by uploading or posting any content from or on the Site, through the Applications, you are indicating that you have read, understood, and consent to be bound by these terms and receive our Services ("Terms of Services" or "Terms").
3. Please read these Terms of Service carefully before accessing or using the Site, Application, or Services, or uploading or posting any material from or on the Site, Application, or Services, as they provide essential details about your legal rights, remedies, and obligations.
4. You have no right to access or use the Site, Application, Services, or Collective Content if you do not agree to these Terms (as defined below).
5. These Terms of Service are binding between you and Parihaa if you use the Site, Application, or Services.

2. Definition

In addition to other words and expressions that may be defined elsewhere in these Terms, unless the context otherwise requires, the following capitalized terms wherever used in the Agreement shall have the meanings as ascribed hereunder:

1. "Courses" means all courses listed on the Site or Application.
2. "Course Fees" means the amounts that are due and payable by a Student for enrolment of Course.
3. "Content" means text, graphics, images, music, software (excluding the Application), audio, video, information or other materials.
4. "Listing" means Courses that are listed by Parihaa as available via the Site, Application, and Services.

6. "Member" refers to anyone who completes Parihaa's account registration process, which includes but is not limited to Teachers and Students, as defined in Clause 7 below under "Account Registration."
7. Any Content that a Member shares, uploads, publishes, submits, transmits, or includes in their Listing, Member profile, or Parihaa promotional campaign that is made available via the Site, Application, or Services is referred to as "Member Content."
8. "Payment Method" refers to a credit card, debit card, or net banking account that you have attached to your Parihaa Account.
9. "Student" refers to a Member who enrolls in Courses through the Application or the Site, or, in the case of a minor student, the parent or guardian who enrolls their child or ward in Courses through the Application or Site.
10. "Tax" or "Taxes" refers to any sales taxes, value added taxes (VAT), goods and services taxes (GST), service tax, and other related local, state, federal, and national indirect or other withholding and personal or corporate income taxes that Parihaa may be required by law to collect and remit to governmental agencies.
11. "Teacher" refers to a Parihaa Member who has been chosen to provide services through the Site or Application.
12. All Content that Parihaa makes available via the Site, Application, Services, or related promotional campaigns and official social media platforms, including any Content licenced from a third party, but excluding Student Content, is referred to as "Parihaa Content."

3. Terms of Service

1. By using the Site, Applications or Services, you agree to comply with and be legally bound by the terms and conditions of these Terms, whether or not you become a registered user of the Services. These Terms govern your access to and use of the Site, Application and Services and all Collective Content (defined above), and constitute a binding legal agreement between you and Parihaa. The user further accepts to allow Parihaa Innovations Private Limited to reach them through call for providing existing services and for providing information on new products and services and will not be subject to DND regulations for such calls.
2. Furthermore, various terms and conditions, requirements, guidelines, or regulations may be posted in certain areas of the Site and Application (and your access to or use of certain aspects of the Services or Collective Content) or you may be required to consent to and accept additional terms and conditions. If these Terms and Conditions and those posted for a particular area of the Site, Application, Services, or Collective Content overlap, the latter terms and conditions would apply to the use of or access to that area of the Site, Application, Services, or Collective Content.
3. You have no right to obtain information from or otherwise continue using the Site, Application, or Services if you do not agree to these Terms. Failure to comply with these

Terms when using the Site, Application, or Services can result in civil and criminal penalties.

4. The Site, Application, and Services are all part of an online portal that allows students to learn about and enrol in courses directly via the Site and Application.
5. You accept and agree that, whether or not you have registered with the Site and Application, by accessing or using the Site, Application, or Services, or by uploading or posting any content from or on the Site or through the Application, you are indicating that you have read, understood, and agree to be bound by these Terms and receive our Services. You have no right to access or use the Site, Application, Services, or Collective Content if you do not agree to these terms. If you approve or consent to these Terms on behalf of a company or other legal entity, you represent and warrant that you have authority to bind that company or other legal entity to these Terms, and "you" and "your" will refer to and relate to that company or other legal entity in that case.

4. GDPR COMPLIANCE STATEMENT

Parihaa respects and complies with the EU General Data Protection Regulations (GDPR). Some of the key ways we comply with these regulations are:

1. Consent

We explain what you are giving right consent to clearly and without 'legalise', and ask that you explicitly consent to contact from us.

2. Breach Notification

In the case of a data breach, we will contact impacted users within 72 hours of learning about it.

3. Right to Access

Users may obtain clarification of whether or not personal data about them is being handled, as well as where and why. In addition, we will have an electronic copy of the personal data.

4. Right to be Forgotten

We may remove your personal data if you have requested it after we have compared your (the subjects') rights to "the public interest in the availability of the data."

5. Data Portability

We offer you the option of receiving your personal data in a "commonly used and machine readable format," and you have the right to send the data to another "controller."

6. Privacy by Design

We effectively enforce necessary technological and organisational steps to secure data subjects' rights.' We only keep and process the data that is absolutely required to carry out our duties (data minimization), and we restrict access to personal data to those who need to carry out the processing.

5. Eligibility

The Site, Application, and Services are only available to those who are legally capable of entering into legally binding contracts under Indian law. The Site, Application, and Services are only for people who are at least 18 years old. If you are under the age of 18, your parent or guardian will create an account on your behalf and assist you in enrolling in courses that are suitable for you. Persons whose membership has been suspended or terminated by Parihaa for any reason are also not permitted to use the Site, Application, or Services. Anyone under the age of 18 is strictly forbidden from accessing or using the Site, Application, or Services. You reflect and warrant that you are at least 18 years old by accessing or using the Site, Application, or Services.

6. Usage of Site, Application or Services

- 1. Students can use the Site, Application, and Services to enrol in courses more easily. Courses like these are mentioned on Parihaa's website, application, and services. As an unregistered visitor to the Site, Application, and Services, you can view Listings; however, if you wish to enrol in Courses, you must first register to establish a Parihaa Account (defined below).**
- 2. Parihaa provides students with access to an online portal that offers a variety of online courses. Unless the Parihaa website expressly states otherwise, Parihaa's duties are limited to promoting the availability of Courses via the Site, Application, and Services.**

7. Account Registration

- 1. You must register to create an account ("Parihaa Account") and become a Member in order to access certain features of the Site and Application, as well as enrol in Courses. You may join the Services by registering directly on the Site or via the Application, or as defined in this section. When Parihaa selects a Teacher to provide services through the Site or Application, he or she is registered and given a username and password (the "Parihaa Account").**
- 2. You may also enter by using our Platform or Application to log into your account with some third-party social networking sites ("SNS ") (including, but not limited to, Facebook; each such account, a "Third-Party Account"), as mentioned below. You can connect your Parihaa Account with Third-Party Accounts as part of the functionality of the Site, Application, and Services by either: I providing your Third-Party Account login details to Parihaa via the Site, Services, or Application; or (ii) allowing Parihaa to access your Third-Party Account, as permitted under the applicable terms and conditions that regulate your use of each Third-Party Account. You represent that you are entitled to disclose your Third-Party Account login information to Parihaa and/or grant Parihaa access to your Third-Party Account (including, but not limited to, for use for the purposes described herein), without breach by you of any of the terms and conditions**

that govern your use of the applicable Third-Party Account and without obligating Parihaa to pay any fees or making Parihaa subject to any usage limitations imposed by such third-party service providers. By granting Parihaa access to any Third-Party Accounts, you agree that Parihaa can access, make available, and store (if applicable) any Content that you have given to and stored in your Third-Party Account (" SNS Content ") on and via the Site, Services, and Application through your Parihaa Account and Parihaa Account profile page. Unless otherwise specified in these Terms, all SNS Content, if any, will be considered to be Member Content for all purposes of these Terms. Depending on the Third-Party Accounts you choose and subject to the privacy settings that you have set in such Third-Party Accounts, personally identifiable information that you post to your Third-Party Accounts will be available on and through your Parihaa Account on the Site, Services and Application. Please note that if a Third-Party Account or associated service becomes unavailable or Parihaa's access to such Third-Party Account is terminated by the third-party service provider, then SNS Content will no longer be available on and through the Site, Services and Application. You have the ability to disable the connection between your Parihaa Account and your Third-Party Accounts, at any time, by accessing the "Settings" section of the Site and Application. Please keep in mind that your relationship with the third-party service providers affiliated with your third-party accounts is solely regulated by the terms of your agreement(s) with them. Parihaa makes no attempt to check any SNS Content for any reason, including accuracy, legality, or non-infringement, and Parihaa is not responsible for any SNS Content.

3. Based on the personal information you provide to us or that we obtain through an SNS as mentioned above, your Parihaa Account and your Parihaa Account profile page will be generated for your use of the Site and Application. You can only have one (1) active Parihaa Account at a time. During the registration process, you consent to provide reliable, current, and complete information, as well as to update such information to keep it accurate, current and complete.. Parihaa reserves the right to suspend or terminate your Parihaa Account and your access to the Site, Application and Services if you create more than one (1) Parihaa Account, or if any information provided during the registration process or thereafter proves to be inaccurate, fraudulent, not current, incomplete, or otherwise in violation of these Terms.
 4. You are solely responsible for the security of your password. You accept that you will not share your password with anyone else and that you will be solely responsible for all activities and acts carried out under your Parihaa Account, whether or not you have approved them. Any unauthorised use of your Parihaa Account will be immediately reported to Parihaa.
8. Course Listings
1. The information about the Course, including, but not limited to, the subject, topic, number of sessions, mode of conduct, and time slots of the lectures, as well as pricing and related rules and financial terms, will be mentioned on the Site and the Application by Parihaa. The Site, Application, and Services can make listings accessible to the general public. You understand and agree that the placement or ranking of Listings in search results may depend on a variety of factors, including, but not limited to Students preferences, ratings.

2. Students will be able to view Courses via the Site, Application, and Services based on the details given in the Listing, as well as the requirements and expectations of the students. We understand and accept that if a Student requests enrolment in a Course, We will not ask the Student to pay a price that is higher than the one stated on the Site or in the Application.
3. Please be aware that Parihaa takes no responsibility for a Student's adherence to any agreements with or obligations to third parties, as well as relevant laws, rules, and regulations. Parihaa reserves the right to delete or disable access to any Student at any time and without warning for any purpose that Parihaa deems intolerable for any reason, in breach of these Terms or Parihaa's then-current Standards, Trademark & Branding Guidelines, or otherwise detrimental to the Site, Application, or Services.
4. If you are a Teacher, you acknowledge and accept that your relationship with Parihaa is limited to that of a Member and an independent, third-party contractor, and that you are not an employee, representative, joint-venturer, or partner of Parihaa in any way, and that you work solely on your own behalf and for your own good, not on behalf of or for the benefit of Parihaa. Your offline account is not under Parihaa's jurisdiction. As a Member you agree not to do anything to create a false impression that you are endorsed by, partnering with, or acting on behalf of or for the benefit of Parihaa, including by inappropriately using any Parihaa intellectual property.
5. When you register for a Course, you will be asked to upload some details, such as a profile picture or a phone number verification. These conditions must be met for any Member who wishes to enrol in one of the Courses.

9. No Endorsement

Through using the Site, Application, or Services, you accept that any legal redress or responsibility you pursue for other Members' or third-acts party's or omissions will be limited to a lawsuit against the specific Members or third parties who caused you harm. You agree not to hold Parihaa liable or pursue any legal redress from them in connection with such acts or omissions.

10. Payment Terms

1. If an enrolment is requested for any Course via the Site, Application or Services, We will either pre-approve, confirm or reject the enrolment request within the period of 7 days from the date of request for enrolment (' Enrolment Request Period'), otherwise the enrolment request will automatically expire. If We are unable to confirm or decide to reject an enrolment request within the Enrolment Request Period, any amounts collected by Parihaa for the requested enrolment will be refunded to the concerned Student. When We confirm an enrolment requested by a Student, Parihaa will send the Student an email, text message or message via e-mail and the Application confirming such enrolment, depending on the selections you make via the Site, Application and Services.
2. The Course Fees payable will be displayed to the Student before the Student sends an enrolment request to Parihaa. Upon receipt of the Students enrolment request, Parihaa

may initiate a pre-authorization and/or charge a nominal amount to Student's Payment Method pursuant to the Payments Terms. If a requested enrolment is cancelled (before any tuitions are provided), any amounts collected by Parihaa will be refunded to such Student, depending on the selections the Student makes via the Site and Application, and any pre-authorization of Student's Payment Method will be released, if applicable.

3. Parihaa will collect the Course Fees from Students at the time of the enrolment request.
4. Parihaa agrees that no refunds will be provided for tuitions already paid, and that, in accordance with the cancellation policy reflected in the relevant Listing, it will allow the Student to cancel the enrolment and (ii) refund the portion of the Course Fees listed in the applicable cancellation policy to the Student. In the event that the related Listing does not have a cancellation policy, the refund amount would be pro-rata to the unconsumed portion of the tuition.
5. You accept that Parihaa, through its Site or Application, will send a system-generated invoice to the Student in connection with the Course for which the Student has enrolled or any other payment made, in accordance with applicable laws. Parihaa will issue an invoice for the items mentioned above, which will include all applicable taxes.
6. In accordance with your Parihaa Account, you as a Student agree to pay the Course Fees for any enrolment requested. The Course Fees will be collected by Parihaa in accordance with the Payments Terms.
7. You will receive a confirmation email summarising your confirmed enrolment once your confirmed enrolment transaction is complete.

11. Cancellations and Refunds

1. If you, as a Student, wish to cancel a confirmed enrolment made via the Site or the Application after enrolling in the Course, the cancellation policy set forth in the relevant Listing will apply, provided that no refund will be given for tuitions already paid. Our ability to refund the Course Fees and other amounts charged to you will depend upon the terms of the applicable cancellation policy and financial charges applicable in case of course payment through No Cost EMI options. The Site and Application provide information on refunds and cancellation policies. Any refunds that are due will be handled by Parihaa in accordance with the Payments Terms. For the most up-to-date terms and conditions for different types of listings/courses, please see the Refunds section of the FAQs.
2. If we cancel a verified enrollment made via the Site, Services, or Application, I Parihaa will refund the Course Fees charged by the relevant Student for such enrollment in accordance with the Payments Terms, but not more than the total sum paid by the Student. If you contact us within 24 hours of placing your order, we may cancel it. The request should be sent to study@parihaa.com with your email address and phone number from the registration process.

12. Taxes

You recognise and agree that where your office or residence is located, relevant governmental agencies, offices, or authorities (the "Tax Authority") may require Taxes to be collected from Students on the sum paid for the Course and remitted to the respective Tax Authority. Since local laws may vary, these Taxes may be expected to be collected and remitted as a percentage of Parihaa's Course Fees.

13. User Conduct

You recognise and accept that you are solely responsible for following all applicable laws, rules, regulations, and tax obligations while using the Site, Application, Services, and Collective Content. You may not, and you consent not to, in connection with your use of the Site, Application, Services, and Collective Content:

- 1. violate any local, state, national, or other law or regulation, or any order of a court, including, without limitation, Tax regulations;**
- 2. access, "scrape," "crawl," or "spider" any web pages or other resources found in the Site, Application, Services, or Collective Content using manual or automated software, computers, scripts, robots, backdoors, or other means or processes;**
- 3. expose or allow to be used or disclosed any Parihaa Content: I that is not publicly displayed by Parihaa in its search results pages or listing pages until an enrolment is confirmed; (ii) in any way that is inconsistent with Parihaa's Privacy Policy or Terms of Service; or (iii) in any way that otherwise violates the privacy rights or any other rights of any individual rights of Parihaa's users or any other third party;**
- 4. use the Site, Application, Services, or Collective Content for any commercial or non-commercial purposes not specifically permitted by these Terms, or in a way that falsely implies Parihaa support, collaboration, or otherwise misleads others about your association with Parihaa;**
- 5. dilute, tarnish or otherwise harm the Parihaa brand in any way, including through unauthorized use of Collective Content, registering and/or using Parihaa or derivative terms in domain names, trade names, trademarks or other source identifiers, or registering and/or using domains names, trade names, trademarks or other source identifiers that closely imitate or are confusingly similar to Parihaa domains, trademarks, taglines, promotional campaigns or Collective Content;**
- 6. For purposes not specifically allowed by these Terms, you may not copy, store, or otherwise access or use any information found on the Site, Application, Services, or Collective Content.**
- 7. infringe on Parihaa's or anyone else's rights, including, but not limited to, their intellectual property, anonymity, publicity, or contractual rights**
- 8. use viruses, cancel bots, Trojan horses, harmful code, flood pings, denial-of-service attacks, backdoors, packet or IP spoofing, forged routing or electronic mail address information, or similar methods or technology to interfere with or damage our Site, Application, or Services;**

9. use our Site, Application, or Services to send, distribute, publish, or submit any information about another person or organisation, including, but not limited to, photographs of others taken without their permission, personal contact information, or credit, debit, calling card, or account numbers;
10. use our Site, Application, Services, or Collective Content to send unsolicited commercial email ("spam") or advertisements that are not connected to lodging in a private residence;
11. collect or store any personally identifiable information about any other user other than for the purposes of transacting as a Parihaa Student; "stalk" or annoy any other user of our Site, Application, Services, or Collective Content;
12. register for more than one Parihaa Account or register for a Parihaa Account on behalf of someone other than yourself, unless the parent is registering for their child or the guardian is registering for their ward;
13. contacting another Member for some purpose other than inquiring about an Enrolment, Course, Listing, or the Member's use of the Site, Application, or Services;
14. without Parihaa's prior written approval, hire or otherwise solicit any Member to enter third-party services or websites that are competitive to Parihaa;
15. without Our prior written approval, hire or otherwise solicit any Member to join third-party services, applications, or websites;
16. impersonate someone or something, or falsify or misrepresent yourself or your relationship with someone or something;
17. use automated scripts to collect data from the Site, Application, Services, or Collective Content, or to communicate with the Site, Application, Services, or Collective Content in some other way;
18. use the Site, Application, Services, or Collective Content to find a Student and then enrol in a Course without using the Site, Application, or Services, in order to avoid paying any Fees relevant to Parihaa's provision of the Services or for any other reason;
19. infringe on these Terms or Parihaa's then-current Policies and Standards;
20. engage in disruptive, circumventive, abusive or harassing behaviour in any area or aspect of our Platform, Application, or Services;
21. post, upload, publish, submit or transmit any Content that: (i) infringes, misappropriates or violates a third party's patent, copyright, trademark, trade secret, moral rights or other intellectual property rights, or rights of publicity or privacy; (ii) violates, or encourages any conduct that would violate, any applicable law or regulation or would give rise to civil liability; (iii) is fraudulent, false, misleading (directly or by omission or failure to update information) or deceptive; (iv) is

defamatory, obscene, pornographic, vulgar or offensive; (v) promotes discrimination, bigotry, racism, hatred, harassment or harm against any individual or group; (vi) is violent or threatening or promotes violence or actions that are threatening to any other person; or (vii) promotes illegal or harmful activities or substances;

22. systematically retrieve data or other content from our Site, Application or Services to create or compile, directly or indirectly, in single or multiple downloads, a collection, compilation, database, directory or the like, whether by manual methods, through the use of bots, crawlers, or spiders, or otherwise;
 23. use, display, mirror or frame the Site, Application, Services or Collective Content, or any individual element within the Site, Application, Services or Collective Content, Parihaa's name, any Parihaa trademark, logo or other proprietary information, or the layout and design of any page or form contained on a page in the Site, Application or Services, without Parihaa's express written consent;
 24. access, tamper with, or use non-public areas of the Site, Application or Services, Parihaa's computer systems, or the technical delivery systems of Parihaa's providers;
 25. attempt to probe, scan, or test the vulnerability of any Parihaa system or network or breach any security or authentication measures;
 26. avoid, bypass, remove, deactivate, impair, descramble, or otherwise circumvent any technological measure implemented by Parihaa or any of Parihaa's providers or any other third party (including another user) to protect the Site, Services, Application or Collective Content;
 27. forge any TCP/IP packet header or any part of the header information in any email or newsgroup posting, or in any way use the Site, Services, Application or Collective Content to send altered, deceptive or false source-identifying information;
 28. attempt to decipher, decompile, disassemble or reverse engineer any of the software used to provide the Site, Services, Application or Collective Content;
 29. advocate, encourage, or assist any third party in doing any of the foregoing; or
 30. accept or make a payment for Course Fees outside Parihaa. If you do so, you acknowledge and agree that you: (i) would be in breach of these Terms; (ii) accept all risks and responsibility for such payment, and (iii) hold Parihaa harmless from any liability for such payment.
2. Parihaa has the right to investigate and prosecute violations of any of the above to the fullest extent of the law. In addition, and as set in these Terms, Parihaa may take a range of actions against you, including but not limited to deactivating or cancelling Parihaa Account, for a violation of this Section or these Terms.
 3. Parihaa may access, preserve and disclose any of your information if we are required to do so by law, or if we believe in good faith that it is reasonably necessary to (i) respond to claims asserted against Parihaa or to comply with legal process (for example,

summons or warrants), (ii) enforce or administer our agreements with users, such as these Terms, (iii) for fraud prevention, risk assessment, investigation, customer support, product development and debugging purposes, or (iv) protect the rights, property or safety of Parihaa, its users, or members of the public.

4. You acknowledge that Parihaa has no obligation to monitor your access to or use of the Site, Application, Services or Collective Content or to review or edit any Member Content, but has the right to do so for the purpose of operating and improving the Site, Application and Services (including without limitation for fraud prevention, risk assessment, investigation and customer support purposes), to ensure your compliance with these Terms, to comply with applicable law or the order or requirement of a court, administrative agency or other governmental body, to respond to content that it determines is otherwise objectionable or as set forth in these Terms.
5. Parihaa reserves the right, at any time and without prior notice, to remove or disable access to any Collective Content that Parihaa, at its sole discretion, considers to be objectionable for any reason, in violation of these Terms or otherwise harmful to the Site, Application or Services.

14. Child Safety Policy

This policy is applicable to all persons and organizations associated with Parihaa, referred to as Parihaa's Stakeholders, including:

1. Employees of Parihaa, who maybe full-time or part-time employees, permanent or temporary employee, regular permanent employee or employed on contract
2. Organizations and persons belonging to that organization, who may partner and/ or work with Parihaa in any capacity, even for a limited time period or job
3. Volunteers who may work with Parihaa, in whichever capacity, even for a limited period of time
4. Children enrolled as students of Parihaa and their parents or guardians who associate with the child in the official records of Parihaa
5. Children who may not be enrolled but are reached out through marketing or sales of the product and their parents or guardians who associate with the Child
6. Any other person or organisations who may be officially associated with Parihaa and its ambit of work and activity

In instances and circumstances where Parihaa may not have required control over the person alleged of any concern under this policy, including an instance of child abuse, Parihaa shall provide the required cooperation, assistance and support to such parent or guardian of the affected child, in approaching any external, legal mechanism including the Police and/or the Courts, though Parihaa is itself not personally liable in such instances.

Parihaa expects all its stakeholders falling within the scope of this policy [Part A (II)] to adhere to the following child safety code of conduct :

1. Expected Behaviour and Actions

- 1. Listen to the child and, their views and opinions**
- 2. Have a non-judgmental attitude**
- 3. Treat every child with empathy and respect regardless of his/her race, colour, gender, sexuality, religion, language, heritage, religious belief, social origin, or any point that discriminated a child**
- 4. Use appropriate language, behaviours while interacting with the child**
- 5. Use appropriate language, behaviours in any online medium used by the organisation to communicate or engage with children**
- 6. Create an environment that enables children to share and express freely**
- 7. Always take permission and written consent from guardian before taking photos or videos of a child**
- 8. Keep all personal information of children, their parents and guardians confidential and secure, such information shall only be shared with authorised individuals**
- 9. The live online classes and the content, including but not limited to audio visual content is age appropriate and culturally appropriate**

2. Prohibited Behaviours and Actions

- 1. Do not develop, induce or support any emotional, online/offline physical abuse or sexual relationship with children in any way**
- 2. Do not use or encourage the use of alcohol, drugs, cigarettes or other intoxicating substance in any of your interaction with children**
- 3. Do not develop any form of relationship or arrangement with children including but not limited to financial, which could be deemed to be exploitative or abusive**

By accessing or using the Site, Application or Services or by downloading or posting any content from or on the Site, via the Applications, you would be indicating that you have read, and that you understand and agree to be bound by these terms and receive our Services (" **Terms of Services**" or "**Terms**"), whether or not you have registered with the Site and/or Application.
3. Therefore, please read these Terms of service before accessing or using the Site, Application or Services or downloading or posting any content from or on the Site, via the Application or through the Services, carefully as they contain important information regarding your legal rights, remedies and obligations.
4. If you do not agree to these Terms, then you have no right to access or use the Site, Application, Services, or Collective Content (as defined below).

5. If you are using the Site, Application or Services then these Terms of Service are binding between you and Parihaa.

2. Definition

In addition to other words and expressions that may be defined elsewhere in these Terms, unless the context otherwise requires, the following capitalized terms wherever used in the Agreement shall have the meanings as ascribed hereunder:

Without limiting our rights specified below, Parihaa may terminate this Agreement for convenience at any time by giving you 30 days' notice via email to your registered email address.

3. Termination for breach, suspension and other measures

1. Parihaa may immediately, without notice terminate this Agreement if (i) you have materially breached these Terms or our Policies, including but not limited to any breach of your warranties outlined in these Terms or breach of the "**User Conduct**" provisions in these Terms, (ii) you have provided inaccurate, fraudulent, outdated or incomplete information

during the Parihaa Account registration, or Listing process or thereafter, (iii) you have violated applicable laws, regulations or third party rights, or (iv) Parihaa believes in good faith that such action is reasonably necessary to protect the safety or property of other Members, Parihaa or third parties, for fraud prevention, risk assessment, security or investigation purposes.

2. In addition Parihaa may deactivate or delay reviews, or other Member Content, cancel any pending or confirmed enrolments, limit your use of or access to your Parihaa Account and the Site, Application or Services, temporarily or permanently revoke any special status associated with your Parihaa Account, or temporarily or permanently suspend your Parihaa Account if (i) you have breached these Terms or our Policies, including material and nonmaterial breaches and receiving poor ratings from Students, or (ii) Parihaa believes in good faith that such action is reasonably necessary to protect the safety or property of Members, Parihaa or third parties, for fraud prevention, risk assessment, security or investigation purposes.
3. In case of non-material breaches and where appropriate, you will be given notice of any measure by Parihaa and an opportunity to resolve the issue to Parihaa's reasonable satisfaction.

4. Consequences of Termination

1. If we take any of the measures described above we may (i) communicate to the Students that a pending or confirmed enrolment has been cancelled, (ii) refund the Students in full for any and all confirmed enrolments, irrespective of pre-existing cancellation policies, (iii) support the Students, on an exceptional basis, in finding potential alternative Courses, and (iv) you will not be entitled to any compensation for confirmed enrolments that were cancelled.
2. If You or We terminate this Agreement, we do not have an obligation to delete or return to you any of your Member Content, including but not limited to any reviews or Feedback. When this Agreement has been terminated, you are not entitled to a restoration of your Parihaa Account or any of your Member Content. If your access to or use of the Site, Application and Services has been limited or your Parihaa Account has been suspended or this Agreement has been terminated by us, you may not register a new Parihaa Account or attempt to access and use the Site, Application and Services through other Parihaa Accounts.

26. Survival

If you or we terminate this Agreement, the clauses of these Terms that reasonably should survive termination of the Agreement will remain in effect.

27. Disclaimers

1. If you choose to use the Site, Application, Services or Collective Content, you do so at your sole risk. You acknowledge and agree that Parihaa does not have an obligation to conduct background or character checks on any Member, but may conduct such background or character checks in its sole discretion. If we choose to conduct such checks, to the extent permitted by applicable law, we disclaim warranties of any kind, either express or implied, that

such checks will identify prior misconduct by a user or guarantee that a user will not engage in misconduct in the future.

2. The Site, Application, Services and Collective Content are provided "as is", without warranty of any kind, either express or implied. Without limiting the foregoing, Parihaa explicitly disclaims any warranties of merchantability, fitness for a particular purpose, quiet enjoyment or non-infringement, and any warranties arising out of course of dealing or usage of trade. Parihaa makes no warranty that the site, application, services, collective content, including, but not limited to, any Courses, will meet your requirements or be available on an uninterrupted, secure, or error-free basis. Parihaa makes no warranty regarding the quality of any Listings, Courses, teachers, Students, the Services or Collective Content or the accuracy, timeliness, truthfulness, completeness or reliability of any collective content obtained through the Site, Application or Services.
3. No advice or information, whether oral or written, obtained from Parihaa or through the Site, Application, Services or Collective Content, will create any warranty not expressly made herein.
4. You are solely responsible for all of your communications and interactions with other users of the Site, Application or Services and with other persons with whom you communicate or interact as a result of your use of the Site, Application or Services, including, but not limited to, any Students. You understand that Parihaa does not make any attempt to verify the statements of users of the Site, Application or Services or to review any Course. Parihaa makes no representations or warranties as to the conduct of users of the Site, Application or Services or their compatibility with any current or future users of the Site, Application or Services. You agree to take reasonable precautions in all communications and interactions with other users of the site, application or services and with other persons with whom you communicate or interact as a result of your use of the Site, Application Or Services, including, but not limited to, Students, particularly if you decide to meet offline or in person regardless of whether such meetings are organized by Parihaa. Parihaa explicitly disclaims all liability for any act or omission of any Student or other third party.

28. Limitation of Liability

1. You acknowledge and agree that, to the maximum extent permitted by law, the entire risk arising out of your access to and use of the Site, Application, Services and Collective Content, your enrolment of any Course via the Site, Application and Services, and any contact you have with other users of Parihaa whether in person or online remains with you. Neither Parihaa nor any other party involved in creating, producing, or delivering the Site, Application, Services, Collective Content will be liable for any incidental, special, exemplary or consequential damages, including lost profits, loss of data or loss of goodwill, service interruption, computer damage or system failure or the cost of substitute products or services, or for any damages for personal or bodily injury or emotional distress arising out of or in connection with these terms, from the use of or inability to use the Site, Application, Services or Collective Content, from any communications, interactions or meetings with other users of the Site, Application, or Services or other persons with whom you communicate or interact as a result of your use of the Site, Application, Services, or from your Enrolment of any Course via the Site, Application And Services, whether based on warranty, contract, tort (including negligence), product liability or any other legal theory, and whether or not Parihaa has been informed of the possibility of such damage, even if a limited remedy set forth herein is found to have failed of its essential purpose.

In no event will Parihaa's aggregate liability arising out of or in connection with these Terms and your use of the Site, Application and Services including, but not limited to, your enrolment of any course via the Site, Application and Services, or from the use of or inability to use the Site, Application, Services, or Collective Content and in connection with any course or interactions with any other members, exceed the amounts you have paid or owe for enrolments via the Site, Application and Services as a student in the three (3) month period prior to the event giving rise to the liability. The limitations of damages set forth above are fundamental elements of the basis of the bargain between Parihaa and you.

29. Indemnification

You agree to release, defend, indemnify, and hold Parihaa and its affiliates and subsidiaries, and their officers, directors, employees and agents, harmless from and against any claims, liabilities, damages, losses, and expenses, including, without limitation, reasonable legal and accounting fees, arising out of or in any way connected with (a) your access to or use of the Site, Application, Services, or Collective Content or your violation of these Terms; (b) your Member Content; (c) your (i) interaction with any Member, (ii) enrolment of an Course; including but not limited to any injuries, losses, or damages (compensatory, direct, incidental, consequential or otherwise) of any kind arising in connection with or as a result of an enrolment or attending of a Course.

30. Entire Agreement

Except as they may be supplemented by additional Parihaa policies, guidelines, standards, or terms for a specific product, feature, service or offering, these Terms constitute the entire and exclusive understanding and agreement between Parihaa and you regarding the Site, Application, Services, Collective Content (excluding Payment Services), and any enrolments made via the Site, Application and Services (excluding Payment Services), and these Terms supersede and replace any and all prior oral or written understandings or agreements between Parihaa and you regarding enrolments, the Site, Application, Services, and Collective Content (excluding Payment Services).

31. Notices

Any notices or other communications permitted or required hereunder, including those regarding modifications to these Terms, will be in writing and given by Parihaa (i) via email (in each case to the address that you provide) or (ii) by posting to the Site or via the Application. For notices made by e-mail, the date of receipt will be deemed the date on which such notice is transmitted.

32. Governing Law and Jurisdiction

1. These Terms and your use of the Services will be interpreted in accordance with the laws of India excluding its rules on conflicts of laws. You and we agree to submit any dispute arising under these Terms to the personal jurisdiction of a court located in Bangalore for any actions for which the parties retain the right to seek injunctive or other equitable relief in a court of competent jurisdiction to prevent the actual or threatened infringement, misappropriation or violation of a party's copyrights, trademarks, trade secrets, patents, or other intellectual property rights.
2. Any dispute, claim or controversy arising out of or relating to this Terms including the determination of the scope or applicability of this Terms to arbitrate, or your use of the

Application or information to which it gives access, shall be determined by arbitration in India, before a sole arbitrator mutually appointed by Members and Parihaa. Arbitration shall be conducted in accordance with the Arbitration and Conciliation Act, 1996. The seat of such arbitration shall be Bangalore. All proceedings of such arbitration, including, without limitation, any awards, shall be in the English language. The award shall be final and binding on the parties to the dispute.

3. If you are a resident of the European Economic Area (EEA) you have the right to complain to a Data Protection Authority about our collection and use of your personal information. For more information, please contact your local data protection authority in the EEA.

33. No Waiver

The failure of Parihaa to enforce any right or provision of these Terms will not constitute a waiver of future enforcement of that right or provision. The waiver of any such right or provision will be effective only if in writing and signed by a duly authorized representative of Parihaa. Except as expressly set forth in these Terms, the exercise by either party of any of its remedies under these Terms will be without prejudice to its other remedies under these Terms or otherwise. If for any reason a court of competent jurisdiction finds any provision of these Terms invalid or unenforceable, that provision will be enforced to the maximum extent permissible and the other provisions of these Terms will remain in full force and effect.

34. Miscellaneous

1. Parihaa shall have no liability of any nature, whether in contract, or otherwise, for any losses whatsoever and howsoever caused, from or in any manner connected with any of the Services provided by Us.
2. Parihaa is not liable for any failure or delay of performance (or otherwise) arising out of a cause beyond Parihaa's reasonable control.
3. You may not assign or transfer these Terms, by operation of law or otherwise, without Parihaa's prior written consent. Any attempt by you to assign or transfer these Terms, without such consent, will be null and of no effect. Parihaa may assign or transfer these Terms, at its sole discretion, without restriction. Subject to the foregoing, these Terms will bind and inure to the benefit of the parties, their successors and permitted assigns.
4. Parihaa reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, the Services (or any part thereof) provided by Us with or without notice. You agree that Parihaa shall not be liable to You or to any third party for any modification, suspension or discontinuance of such Services. It is Your responsibility to review these Terms periodically for updates/changes.
5. You agree not to reproduce, duplicate, copy, sell, resell or exploit for any commercial purposes, any portion of the information provided by us, including any intellectual property rights of Parihaa or any person firm or corporation having posted information for availability through the Services provided by us.

6. You agree that in the event Your post or Your information violates any provision of this Terms, We shall have the right to refuse to provide You or any person acting on Your behalf, access to the Site and Application, terminate and/ or suspend Your access if applicable in the future.
